Memorandum of Understanding (MOU)

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into on this 5th day of Feb, 2019, between **B.N. College, Bhagalpur**, located at Lower Nathnagar Road, Bhagalpur, 812007 and **Majusha Craft**, located at Mohaddinagar, Mirjanhat, Bhagalpur, 812005

Background:

The Academic Institute and the Art Institute recognize the mutual benefits of collaboration in the fields of education, research, and cultural exchange. Both institutions aim to promote interdisciplinary learning and foster creativity among students, faculty, and staff. This MOU outlines the terms and conditions under which the Academic Institute and the Art Institute agree to collaborate.

Agreement:

- 1 **Objective:** The primary objective of this MOU is to facilitate cooperation and exchange between the Academic Institute and the Art Institute in areas of mutual interest, including but not limited to:
 - Joint research projects.
 - Exchange of faculty, researchers, and students.
 - Collaborative educational programs.
 - Cultural events and exhibitions.
 - Sharing of resources and facilities.
- 2 **Areas of Collaboration:** Both parties agree to explore and undertake collaborative initiatives in the following areas:
 - Development of interdisciplinary courses or modules.
 - Organization of workshops, seminars, and conferences.
 - Coordinated efforts in securing grants and funding for joint projects.
 - Publication and dissemination of research findings.
 - Artistic performances and exhibitions.
- 3 **Responsibilities:**
 - The Academic Institute shall provide access to its academic resources, including libraries, laboratories, and expertise.
 - The Art Institute shall facilitate access to its artistic facilities, studios, and specialized equipment.
- 4 **Exchange Programs:** Both institutions agree to facilitate the exchange of faculty, researchers, and students to enhance learning and cultural understanding.
 - Exchange programs may include short-term visits, semester-long exchanges, or joint degree programs.
 - Terms and conditions of exchange programs shall be mutually agreed upon by both parties and documented separately.
- 5 **Intellectual Property:** Intellectual property rights arising from collaborative projects shall be governed by separate agreements between the parties involved, adhering to applicable laws and regulations.
- 6 **Confidentiality:** Both parties agree to maintain confidentiality regarding sensitive information shared during the course of collaboration.
- 7 **Duration:** This MOU shall come into effect on the date of signature by both parties and shall remain in force for a period of 6 years. It may be extended by mutual written consent.
- 8 **Amendments:** Any amendments or modifications to this MOU shall be made in writing and duly signed by authorized representatives of both parties.

This MOU constitutes the entire understanding between the B.N. College, Bhagalpur and the Manjusha Craft and supersedes all prior agreements, whether written or oral, relating to the subject matter herein.
